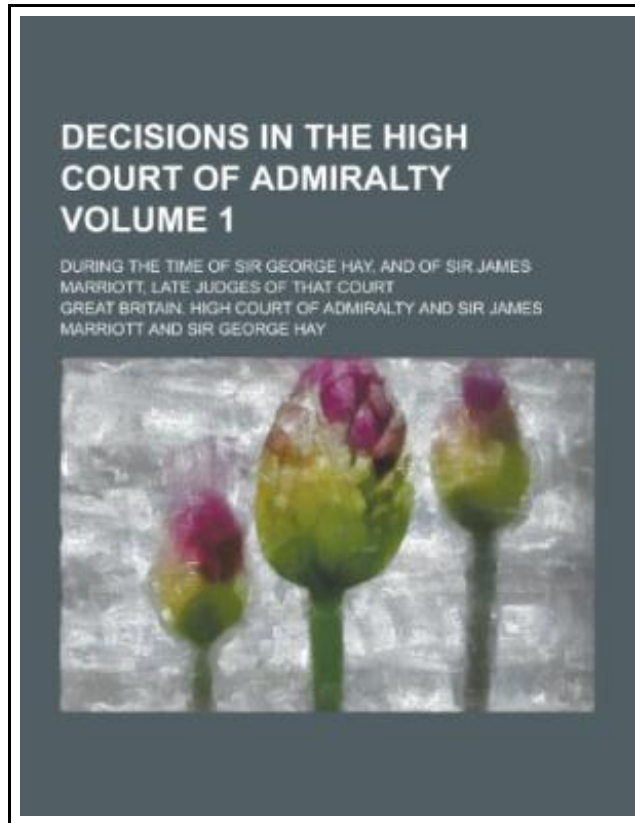

All the bills of lading were defective in not expressing upon whose account and risk the several parts of the cargo were shipped; and several referred to acquittances under bond, of which the Captain was therein declared to be the bearer. November 27, the Court restored the ship as the property of Lubeckers, with freight and expenses of the Master, to be charged upon the cargo; and decreed further proof of property to be made by all parties who might have interest. No other claims being given in, the cause came on to be heard upon further proof of property by affidavits, with consent of parties. In regard to Martinus Tak, a certificate was offered, made by the magistrates of Middleburgh, of Zealand in Holland, dated December 17, 1778, setting forth that Tak, being of the Menonite persuasion of religion, (a sort of Quakers) had solemnly affirmed before them, that the Chollet handkerchiefs were his own goods at the time they were laden, and continue to be his true property to this present time, and so they were belonging to him in full property at the time the ship was taken as prize and will be, at the time of their arrival here at Middleburgh; that they were the same as in the bills of lading and that the King of France, his vassals or subjects, or inhabitants of that country, territories or dominions, never had, neither have they at this present...
